Course Objectives:

After completing the course, students will be able to:

- Describe the four phases of emergency management
- Making distinctions between natural and technological or man-made hazards
- Discuss the concept of acceptable risk in terms of individual and community exposure to natural and/or technological hazards
- Discuss the role of government in managing natural and technological hazards
- Describe the general evolution of emergency management in the U.S.
- Describe and discuss the legal and political relationships among federal, state, and local emergency management agencies
- Describe and discuss the concept of "all-hazards" emergency management
- Describe and discuss the Integrated Emergency Management System (IEMS) model
- Describe and discuss the kinds of problems that can occur when programs require intra-governmental, multi-organizational, cooperation
- Discuss basic planning concepts
- Select emergency exercise types based on desired outcomes
- Identify future trends in emergency management

Course Description:

This course is designed to introduce students to the fundamental concepts, theories, principles and practices in emergency management.

Course Structure:

This class will consist of mini video lectures from the instructor, PowerPoint presentations, case studies/book review, quizzes, exams, an introduction to FEMA training, a virtual visit to the State of Florida's Emergency Operations Center and an applied Tabletop Exercise System Technology (TEST) exercise to give you a feel for the types of decisions to be made in an emergency event.
